

## **DIMS** organisation and goals




- To know which recreational drugs are currently being used and what changes in drug use are seen over time (monitoring).
- Identifying possible additional health risks and initiating and performing warning campaigns (surveillance).

 Harm reduction towards a group of users not generally seen at other services (prevention).








## What is DIMS?



The Drugs Information and Monitoring System is a national network of testing facilities that aims at gaining insights into the market of controlled substances.

## What does DIMS do?



**Activities:** DIMS examines the content of drugs and their associated health risks, and analyses trends.

Method: DIMS monitors the markets of scheduled substances by offering consumers the possibility to have their drugs tested.

**Application:** The data collected are being used for education, prevention and policy interventions.

**Education:** The testing facilities serve a major educational purpose and provide information on effects and risks of drugs.

Warnings: DIMS occasionally warns at a national, regional or local level, or e.g. via social media for drugs involving extra risks.

## **Measurements - Procedure on Location**



DIMS affiliated organizations hold weekly consulting hours.



Here, users are able to hand in drugs for analysis, anonymously and discretely.



If the sample can be determined, the composition is passed on directly.



If not, the sample is sent to the laboratory for further analysis.



A week later, the drugs have been analysed and the results are communicated.


## Arrangements with national and local authorities

- Users attending a drug checking service will not be arrested or prosecuted, as long as they do not bring more than 3 samples!
- Testers are allowed to handle drugs for testing purposes, but not for dealers or producers!
- Officially documented by The Netherlands Public Prosecution Service

## **Highlights 2021 (1)**



#### Limited testing due to COVID

The COVID pandemic has had a noticeable influence on DIMS in 2021. While our testing sites have been open throughout the year, the varying nationwide restrictions have led to limited testing options compared to pre-COVID.

#### Less samples than pre-COVID

As a result of the pandemic, DIMS has received less samples in comparison to the last pre-COVID years. Still, with 10,302 samples received in 2021, DIMS has tested more than enough samples to sufficiently monitor the drug markets.

#### Little change in sample composition

Minor changes in samples composition: Compared to previous years, there are few noticeable changes in drug sample composition to report. There are noticeable changes in the contents of ecstasy tablets, the cause of which is as of yet unknown.

## Highlights 2021 (2)



#### **Less MDMA in ecstasy tablets**

The average MDMA content per tablet has dropped from 166mg in 2020 to 148mg in 2021. While less extreme than previous years, this does mean that ecstasy tablets are still very strong.

#### Less party drugs due to COVID

Compared to other substances, DIMS has received less party drugs like ecstasy in 2021. This is likely due to the absence of festivals and the nightlife being closed for most of the year.


#### Warnings for DOC and adulterated cannabis

In 2021, DIMS has issued a warning for tablets sold as 2C-B which contained extremely high doses of the potent hallucinogenic DOC. DIMS also warned for cannabis adulterated with synthetic cannabinoids (since 2020). Normally, cannabis is not analyzed as its legal status places it outside the scope of DIMS. However, synthetic cannabinoids are of interest to DIMS.

## Samples submitted (1)



In 2021, 9,257 visitors supplied DIMS with 10,302 samples, more than half of which were ecstasy tablets.



## Ecstasy/MDMA in 2021 (1)



More than half of the samples submitted in 2021 were sold as ecstasy (56%). Nine out of ten ecstasy tablets contain only MDMA as active substance.





## Ecstasy/MDMA in 2021 (3)





There can be large differences in the MDMA content of ecstasy tablets.



On average, a tablet contains 148 mg MDMA (—). Half of the tablets contain between 120 and 180 mg MDMA (■), a quarter less, and a quarter more than that.

## **Cocaine in 2021 (1)**



In 2021, 7.9% of all samples were sold as cocaine.




Average price per gram: € 51.80.

More than half of all cocaine costs exactly 50 euro per gram.



## **Cocaine in 2021 (3)**








Cocaine concentration covering half of the cocaine powders (%)

At 71%, the average cocaine concentration in submitted powder samples is higher than ever.



Cocaine is adulterated relatively often, usually with levamisole.

## **Ketamine in 2021 (1)**




In 2021, 4.1% of all samples were sold as ketamine.

Average price per gram: € 23.80. Half of all ketamine powders cost between 20 and 30 euro.

## **Ketamine in 2021 (2)**





#### **Effects**

- Mind altering
- Out-of-body experience

#### Risks

- Bad trip (k-hole)
- Loss of coordination
- Muscle stiffening or paralysis
- Urinary tract problems

- Only ketamine
  - Ketamine + levamisole
  - Ketamine + adulteration
- No ketamine (and/or levamisole)

Ketamine samples are fairly pure (79% average), but sometimes contain high concentrations of levamisole (62% average).



#### Number of NPS submitted to DIMS (total)




NPS (New Psychoactive Substances) are also known as "designer drugs" and "research chemicals". The substances ketamine, GHB, and 2C-B have already been covered in previous paragraphs, therefore we will only focus on NPS that have not yet been discussed.

## NPS in 2021 (2)



Number of NPS submitted to DIMS (not yet covered in the annual report)



These NPS are often semi-legal or recently scheduled substances that are generally being used by relatively small groups of users with an interest in NPS. Sometimes these substances become popular among a wider audience: prime examples in recent years being 4-FA and 3-MMC. 4-FA in particular showed a huge surge in popularity around 2016, before being banned in 2017.

# Case study 1: N-ethylpentylone and N-ethylhexedrone

- Since week 38 2017: ±25 powder samples sold as 4-FA/NPS containing N-ethylpentylone or N-ethylhexedrone
- Half of the samples bought online, addresses are known.
- N-ethylpentylone: dose of 60 to 80 mg can lead to severe, if not fatal health issues [1].
- N-ethylpentylone has been linked to a great number of ODs and deaths (EMCDDA). In EU mainly in substances sold as MDMA
- For N-ethylhexedrone, a dose of 50 regarded as strong' to 'heavy' dose [2].
- Both substances found in 4-FA: common dose ±150 mg

### Designerdrug 3-MMC verboden




## What has drug checking by DIMS brought the Netherlands?





